



CHANDLER PARKS BOARD MEETING

APRIL, 28TH, 2016

MEMBERS: TODD HURT, KIM BRUNETT, TERRY CUPP, GENE DOCKERY, AND RHONDA HEALY.

Meeting was called to order at 6:01 by President, Todd Hurt.

Roll call: Dockery, Cupp, Hurt, Burnett and Healy. All members present.

Minutes from the March 1st, April 4th and April 14th were read: Burnett made the motion to approve. Seconded by Hurt. 3 yes 1 nay. Motion carried

Comments from citizens not on the agenda: Mcdaniels/Summers from the Chandler Sports Park Inc., informed the Parks Board that they have met and have voted Rob Maurer off the organization. They are contacting him in regards to his key to the concession stand and the transfer of the 501(c) organization to the two of them. The board is now 2 members and they voted the president off the board. McDaniels is currently treasurer. Cps Inc. is to report monthly to the Parks Board. They are looking into forming a new 501(c) if the current organization is not transferred over to them. The dissolution of the current 501(c) organization all monies and any equipment owned must be turned over to the Parks Board. Todd has asked Rob for information but has not received anything yet.

They also reported that they have added July 1st, 2nd and 3rd youth tournament. Adult coed tournament next week.

With the current issues of billing all expenditures approved by the Parks Board will be billed to the town hall.

There has been a problem with golf carts and 4 wheelers in areas where motorized vehicles are not allowed by the public. We will contact Josh in regards to how to handle this without violating the ADA complaint ordinance of the town. Todd made the motion to ban all recreational vehicles from entering the emergency lane excluding motorized wheelchairs. Seconded by Cupp. Motion passed.

New Business: Cupp made the motion to move the Jaycee donation from our general funding to the donation category. Burnett seconded the motion and the motion carried.

Todd asked Sean to check and see who has keys to the Community Center. He will check into this. The discussion on key bobs took place then it better control over who does and does not have access.

Discussion took place on Richard attending the meetings and updating the board on the rental of the Community Center. Sean advised that Richard is an employee of the Parks Board. It was requested that a letter be sent to Richard requesting his attendance to our next meeting. Rhonda will draft and send the letter. Discussion took place that the rental of the community center needs to be on the web site so people will know when it is available.

Burnett made motion for Arflack to get quotes on playground equipment. Dockery seconded the motion and the motion carried.

Old Business: Todd advised that it would only cost \$500.00 to take off the 5th row of bleacher seats and this will eliminate the requirement of the kits to be in compliance.

Field 4 the holes have been filled. All 4 fields are ready to play. The fencing on field 4 is residential fencing which does not meet code. Temporary fencing will be placed for now.

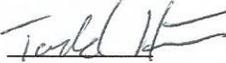

We will have to check with the attorney to see if we are capable of doing this.

At the town maintenance department Todd understands that there is a 4 wheeler and trailers that should belong to the Parks Department.

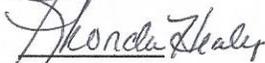
We need to work on the 5 year master plan.
