1. CALLED TO ORDER BY ARFLACK AT 6:03 PM
2. ROLL CALL - MEMBERS PRESENT - ARFLACK, JENKINS, WILLIAMS, BURNETT, CUPP, & WHITLEDGE. ALSO PRESENT WAS DIRECTOR FISHER. MEMBERS ABSENT - LEMMONS
3. DECLARATION OF QUORUM WAS CONFIRMED BY PRESIDENT ARFLACK
4. COMMISSION SAID THE PLEDGE OF ALLEGIANCE
5. READING AND APPROVAL OF PREVIOUS MINUTES -
 1. MONDAY FEBRUARY 12TH, 2018 WAS READ BY DIRECTOR FISHER - MOTION TO ACCEPT BY WILLIAMS, 2ND BY JENKINS - MOTION PASSED 6-0
 2. WEDNESDAY FEBRUARY 14TH, 2018 - MINUTES FROM A PLAN REVIEW WAS READ BY DIRECTOR FISHER - MOTION TO ACCEPT BY WHITLEDGE, 2ND BY CUPP - MOTION PASSED 6-0
6. NEW BUSINESS
 1. BRENT HEALY - PROPERTY AT 763 W. LINCOLN AVE. MOTION WAS MADE BY JENKINS AND 2ND BY CUPP NOT ISSUE ANOTHER BUILDING PERMIT TO MR. HEALY - MOTION PASSED 5-0-1 ABSTAINED - THE COMMISSION HAS MAJOR CONCERNS WITH THIS BUILDING BECAUSE IT IS IN THE FLOOD PLAN AND HAS BEEN FLOODED MANY TIMES - COMMISSIONS RECOMMENDATION IS TO SEND A LETTER TO THE TOWN COUNCIL TO HIRE AN OUTSIDE FIRM TO DO A STRUCTURAL AND ENVIRONMENTAL INSPECTION OF THE BUILDING AND TO ISSUE A STOP WORK ORDER ON THE BUILDING IMMEDIATELY.

SENATE AND IS ON THE GOVERNOR'S DESK FOR HIS
SIGNATURE.

MEETINGS - HE DID SAY HE WOULD HAVE THE AGENDAS
READY FOR BOTH MEETINGS
7. OLD BUSINESS -
1. FISHER REPORTED THAT THE EXTERIOR REMODEL OF 414 S.
STATE ST. HAS A CASING AROUND THE FRONT DOOR THAT
HAS A BUILT IN J CHANNEL - IT WAS REPORTED BY
COMMISSION PRESIDENT THAT THIS JOB NEEDED J CHANNEL
AROUND THE FRONT DOOR

2. DISCUSSION TOOK PLACE ABOUT THE YARD BARN OF MARK WORSTELL - 521 E. LINCOLN AVE. - WHERE A NEW POLE BARN WAS BUILT - MR. WORSTELL INFORMED FISHER THAT THEY WANT TO KEEP THE YARD BARN TO USE AS A POOL HOUSE WHEN THEY PUT IN A POOL THIS SUMMER - FISHER INFORMED THE COMMISSION THAT HE DOES NOT THINK ALL REQUIREMENTS WILL BE MET - SQUARE FOOTAGE OF ALL BUILDINGS AND POOL BEING MORE THAN THE SQUARE FOOTAGE OF THE HOUSE - AS WELL AS MORE THAN 30% OF LOT COVERAGE BY ACCESSORY BUILDINGS AND THE POOL
3. FISHER REPORTED ON THE DRYWALL ISSUE ON THE GARAGE ADDITION AT 7222 GREENWOOD RD. - SINCE THE JOB IS OVER AND THE INSPECTION WAS PASSED - TOWN ATTORNEY CLAYBORN SAID NOTHING CAN BE DONE ABOUT IT AND LET IT GO - FISHER APOLOGIZED TO THE COMMISSION ABOUT HIS MISTAKE
4. THE NEW COMPREHENSIVE ZONING ORDINANCE BOOKS WERE HANDED OUT AND DISCUSSED
5. FISHER REPORTED ON THE POLE BARN JOB AT 8000 GARDNER RD. THAT DOES NOT HAVE THE SIDING PUT ON THE BUILDING YET - THE PERMIT DOES NOT EXPIRE UNTIL OCTOBER 13TH, 2018 - COMMISSION DECIDED TO WAIT UNTIL SUMMER TO SEND THEM A LETTER ABOUT THEIR PERMIT EXPIRING AND THE SIDING NOT BEING FINISHED YET
6. COMMISSION MEMBER BURNETT ASKED ABOUT THE GARAGE ON S. STATE ST. OWNED BY JOHNATHON KNIGHT - THE ZONING WAS IN QUESTION ALONG WITH OLD JUNK CARS WAY BACK IN THE BACK - FISHER SAID HE WILL FOLLOW UP AND REPORT BACK TO THE COMMISSION

- 9. JENKINS REPORTED ON THE ANCHORS FOR YARD BARNs AND METAL BUILDINGS - COMMISSION LOOKED OVER SOME SUGGESTIONS PRESENTED BY JENKINS - JENKINS SAID HE WOULD KEEP ON LOOKING AND MAYBE A TRIP TO A YARD BARN DEALER IN HENDERSON WOULD BE A GOOD IDEA BECAUSE THEY HAVE AN ANCHOR SYSTEM IN PLACE
